In support of electronic communication by email, Non-registered Holders are recommended to provide their functional email addresses to their Intermediaries. If the Company does not receive your functional email address or postal address from your Intermediaries via HKSCC Nominees Limited, no notice of publication of the Website Version of Corporate Communications will be sent to you.

If you have received a notice of publication of Corporate Communications and for any reason have difficulty in gaining access to the Corporate Communications on the Websites and wish to receive the Corporate Communications in printed form, please send your request in writing to the Company’s share registrar in Hong Kong (the “**Share Registrar**”), Tricor Secretaries Limited (email address: asm0522-ecom@hk.tricorglobal.com; postal address: 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong). Upon receipt of the request in writing, the Company will send the requested Corporate Communications in printed form to such Non-registered Holders free of charge.
